PREAMBLE

To the Constitution and Regulation Of International FIADAH

We are not a council. We do not want, nor would we ever want that this concept of wanting to plan is introduced between us, organize, administer, and operate a council.

We, the parents and founders of this Fraternity called FIADAH, like Christ, Peter, Stephen, Paul and many others Christians of the Early Church have suffered the ravages of what is religious power when it is being exercised by a council or a conciliar leader.

Having been this way and after scrutinizing well what The Bible, which is the Holy Word of God, tells us about the councils, we conclude that this form of religious government was the worst enemy of Christ himself, of the apostles, of the Early Church and of the preaching of the Gospel.

Even the apostolic agreement in Jerusalem, which appeared to be good, according to chapter 15 of the book of Acts, he resolved a situation that then it became guidelines that created contests and competitions improper among the apostles themselves and greatly repelled in the conduct of the early church; with the exception where he intervened the person of the Holy Spirit.

An example of this was the dispute or confrontation between the apostle Paul and the apostle Peter, as narrated in Gal: 2: 11-20. Bliss confrontation led the apostle Paul to insert a chapter as it is fourteen within the Epistle to the Romans. We therefore understand that the bitter disputes were the product of the decisions made in said apostolic meeting. We are not a council nor do we want to be Never.

We are a Fraternity of Churches and ministers united by love to recognize, safeguard and promote sovereignty and autonomy of each local church to remain the Lord Jesus Christ the Supreme Authority, the Lord of the Church and the only Prince of Shepherds. Mt. 16: 16-18 and 1st Ped. 5: 1-4.

Let us always learn and practice the principle of government ecclesiastical that the Lord, after having suffered at the hands of the council and see what the apostles and Christians of the early church they suffered too, he left us in the book of Revelation. The Lord Jesus he did not entrust the local church to any council or episcopate. According to messages to the seven churches that would represent the Church at large of the future, Christ dealt directly with each local church through your pastor or church angel. In this is seen autonomy and sovereignty of each local church implicitly approved and respected even by Christ Himself. He did not need any council or episcopate in his treatment with every local church and there was a council of seven churches if not seven churches autonomous who depended independently of the Lord Jesus Christ for his direction and government.

Of course, we need each other! Of course, we must unite and fraternize! But all what should unite us is the perfect bond of love. (Col. 3:14) It should not be the desire for power and greatness, much less yearning to use that power to run over, interrupt, enter, much less damage the harmony and well-being of local churches by underestimating them as if they were not able to understand the Lord's will and the Lord's dealings with them.

If any model of religious organization were necessary, we will have to look it up in the Bible within what the Lord of the church honored and we see that in the seven churches of the book of Revelation. The brotherhood of saints, unity in the Spirit and faith in Sublime hope that one day we will be in the presence of the Lord is what gives us the reason to be like FIADAH.

Let us always defend this principle of voluntary unity that we the parents and founders of this organization receive from part of the Lord no matter how rugged the path may have been or may be in the future. We defend that sovereignty and autonomy that guarantees to the local church their direct contact with our Lord Jesus Christ. Let us be faithful and loyal to that spirit of voluntary unity for love that we distinguish.

We want to record the approval of the Lord to this movement that before completing nine months of existence, since FIADAH had spread from Puerto Rico to the United States of North America, to Venezuela, the Republic Dominican, Bolivia and Colombia. Right now, after those first nine months we are already receiving membership requests from Nicaragua, Honduras, El Salvador, and Guatemala. As I write this Preamble we do it to prevent it from getting up after us leaders who do not know how FIADAH started, which it was the reasons and the principles of unity that gave him his reason for to be. Let us not allow the longing for power, to dominate and to destroy through the force of the selfishness, the fame, the human strategies and demagoguery will get in the way and want to stop growth and to damage the harmony that has characterized us from the beginning.

FIADAH will always be an instrument of God to defend the principle of voluntary unity for love and that every minister and church that one will come to help strengthen this instrument or vehicle facilitator of the sovereignty and autonomy of local churches under the Lordship of Jesus Christ.

It is the local churches, after all, that subsist by their own efforts and sacrifices and that is why the Lord of the church honors and blesses them.

CONSTITUTIONAL DECLARATION

Zeal for the Lord's work, the sovereignty of His kingdom and of what constitutes His kingdom; local churches leads us to organize and constitute ourselves as Hispanic Autonomous Assemblies of God International Fraternity. Every local church must be sovereign and autonomous.

There must be nothing to stop us from carrying out the work of evangelization, worship, and the building of a body of believers which is what really gives the church its reason for being as the body of Christ. Ef. 4:11, 12.

On the other hand, love, which is the perfect bond, is the only thing which must inextricably hold us together in Christ as fraternity of churches and ministries.

Once the doctrines that make up the structure are accepted bone that holds it vertically firm and solid, the fraternity is constitutes in a facilitating agency of communion, the unity and spiritual health of each local church. Hch. 2:41, 42.

Love, unity, and brotherhood will be the way of life and of existence that will characterize our Fraternity and in that same feeling all activities, meetings and deliberations must be available that they take place once organized.

CONSTITUTION

ARTICLE I- NAME AND HEADQUARTERS

The name of this entity will be: International Fraternity Hispanic Autonomous Assemblies of God, Inc.; based in Puerto Rico.

ARTICLE II – TERRITORY

The Lord said that the field is the world. Our Fraternity it will cover, and it will extend to the whole world according to God keep expanding our trajectory although our main purpose would be to reach the entire Spanish-speaking world.

ARTICLE III – NATURE

Everything that this Fraternity does and promotes will be of character voluntary and mutual agreements. Our motto will be "UNITED BY LOVE". Our practice will be one of Christ central nature.

ARTICLE IV – PREROGATIVES

1. Bringing the evangelistic message to lives that do not know Christ as your personal Savior.
2. Freely teach and practice worship of God.
3. Promote the building of believers and therefore of the church as the body of Christ.
4. Christian education in general.
5. The education and training of those called to the Ministry.

6. Promote fellowship among all churches and ministries that make up the Fraternity.
7. Establish and organize entities that help us achieve and promote voluntary unity.
8. Choose your own officers and leaders ensuring the participation of all those interested in said process.
9. That the Fraternity can enjoy the same autonomy and sovereignty that guarantees each local church. This will be accomplished by participation limited only to its active members and militants within the Fraternity.
10. Possession of physical facilities that help the Fraternity to conduct their activities.

ARTICLE V - PRINCIPLES OF UNITY

Voluntary cooperation, love and doctrinal identity will be what unites us as a Fraternity. Mutual respect and consideration just according to the word of God will be our strength.

ARTICLE VI - AUTONOMOUS CHURCHES

Churches will organize and look for ways that once have your statutory congregation avoid or resolve all that that may affect their autonomy and local sovereignty which is ours distinctive.

ARTICLE VII - OUR DOCTRINES

Our doctrine will be based on the Holy Scriptures from which we extract based on synthesis the following truths fundamental:

1. THE INSPIRATION OF THE SACRED SCRIPTURES

Holy Scripture, both Old and New Testament, they are verbally inspired by God and are the revelation of God to man, the infallible

and authoritative rule of faith and conduct. (1 Thess. 2:13; 2 Tim. 3:15 - 17; 2 Pd. 1:21).

2. THE ONLY TRUE GOD

The only True God has revealed Himself as the own existing, eternal "I AM", the Creator of heaven and earth, and Redeemer of humans. He has also revealed himself as incorporating the principles of kinship and association as Father, Son and Holy Spirit. (Dt. 6:14; Is. 43: 1, 11; Mt. 28:19; Lk. 3:22). The adorable deity.

a) Defining the terms

The terms "Trinidad" and "people" as related to the Deity, while not I know find in the scriptures, is it so in harmony with the themselves, therefore we can communicate to others our understanding of doctrine of Christ as existing from God in distinction from "The many gods and the many lords". Therefore, we can speak properly of the Lord our God the which is ONLY ONE LORD as a Trinity and as a BEING three people and at the same time be absolutely within the Holy writings. (Mt. 28:19; Jn. 14:16 - 17; 2 Cor. 13:14).

b) Distinction and kinship of the Deity

Christ taught a distinction of persons in Deity the which he expressed in specific kinship terms as Father, Son and Holy Spirit, but that this distinction and relationship as for its way, it is inscrutable and incomprehensible, for how much is it inexplicable. (Mt. 11:25 - 27; 28:19; Luke 1:35; 1 Co. 1:24; 2 Co. 13:14; 1 Jn. 1: 3-4).

c) The unity of a Being, the Father, the Son, and the Holy Spirit

Consequently, there is in the Son that which constitutes him in the Son and not in the Father, and there is that in the Holy Spirit and not in the Father or in the Son. Therefore, it is the Father who begets, the Son is the begotten and the Holy Spirit is that that comes from the Father and the Son. Consequently, because these three people in Deity are in

perfect unity, there are one Almighty God and one is his name. (Zac. 14: 9; Jn. 1:18, 15:26, 17:11) The Father and the Son and the Holy Spirit never appear identified as for people, nor confused as for to cooperation. The Son is in the Father and the Father is in the Son in as for companionship. The Father does not come from the Son, but the Son proceeds from the Father in authority. The spirit Holy proceeds from the Father and the Son as to their nature, kinship, cooperation, and authority. Accordingly, no of the three persons in the Deity works or exists separately and independent of the others. (Jn. 5:17 - 30, 37; Jn. 8:17, 18).

d) The title "Lord Jesus Christ"

The Title "Lord Jesus Christ" is a proper name. Never neither the Father nor the Spirit applies in the New Testament Holy. It therefore belongs exclusively to the Son of God. (Rom. 1: 1 - 3, 7; 2 Jn. 3)

e) El Señor Jesucristo, Dios con nosotros:

The Lord Jesus Christ, regarding Divine nature and Eternal is the own and Only Begotten Son of the Father, but as for nature human is the legitimate Son of man. Therefore, it is Recognized like God with us. (Mt. 1:23; 1 Jn. 4: 2, 10. 14; Rev. 1:13, 17).

f) The title, Son of God:

Since the name includes both God and man in the same person, our Lord Jesus Christ, it is understood that the title Son of God describes his Deity and the title Son of man, his own humanity. Therefore, the title Son of God belongs to the eternal order and the title Son of man to the temporal order. (Mt. 1:23, 25; Heb. 1: 1-13; 7: 3; 2 Jn. 3).

g) Transgression of the Doctrine of Christ

It is therefore a transgression of the doctrine of Christ saying that Jesus Christ derived his title, Son of God, only from fact of the incarnation or by its relation to the economy redemptive. By consequent, deny that the Father is a Father eternal and real and that the Son is a real and

eternal Son is a denial of distinction and kinship in the Trinity of God, a denial of the Father and the Son and a dislocation of the truth that Jesus Christ is come in the flesh. (Jn. 1: 1; 3:14, 18, 31, 36; I have. 12: 2, 1 Jn. 2:22, 23; 4: 1-5; 2 Jn. 9).

h) Exaltation of Jesus Christ as Lord

The Son of God, our Lord Jesus Christ having made Himself the purge for our sins, He sat at the right hand of the Majesty of the heights, being subjects angels, principalities and powers and having been made Lord and Christ sent the Holy Spirit; so that we, in the name of Jesus, can bend our knees and confess that Jesus Christ is Lord for the glory of God the Father, until the end time, when the Son will be subject to the Father; so that it is all things in everything. (Acts 2:32 - 36; Rom. 14:11; 1Co. 15:24 - 28; Heb. 1: 3; 1 Pd. 3:22).

i) Equal honor to the Son as to the Father

Because the Father has given all judgment to the Son, not it is only the express duty of everyone in heaven and on earth bend the knee before Him, but it is also an undeniable joy in the Holy Spirit ascribe to the Son all the honor and glory manifested in all the names and titles of the Deity (a Except for those indicating kinship, see paragraphs b, c and d) and honor the son as we honor the Father. (Jn. 5:22 - 23; Phil. 2: 6; 1 Pd. 1: 8; Rev. 4: 8-11; 5: 6 - 14; 7: 9, 10).

3. THE DEITY OF OUR LORD JESUS CHRIST

The Lord Jesus Christ is the eternal Son of God. The Scriptures declare:

- a) His virgin births. (Mt. 1:23; Lk. 1:32 -35)
- b) His sinless life. (Heb. 7:26; 1 Pd. 2:22)
- c) His miracles. (Acts 10:38)
- d) His work of substitution on the cross. (1 Cor. 15: 3; 2 Cor. 5:21).
- e) His bodily resurrection from the dead. (Mt. 28: 6; Lk. 24:39; 1 Co. 15: 4)

- f) His exaltation at the right hand of God. (Acts 1: 9, 22; Phil. 2: 9 -eleven; I have. 1: 3)

4. THE FALL OF MAN

Man was created just and good, because God said: "Let us make man in our image, according to our likeness". But the man, by voluntary transgression, fell and therefore not only physical death but also death spiritual, which is separation from God. (Gen 1:26, 27; 2:17, 3: 6; Rom. 5:12 - 19)

5. THE SALVATION OF MAN

The only hope of redemption that man has is to through the blood shed by Jesus Christ, the Son of God.

a) Conditions for salvation

Salvation is received by repentance toward God and faith in the Lord Jesus Christ. Man is saved by the wash of regeneration and the renewal of the Holy Spirit, being justified by grace through faith, becoming heirs of God according to the hope of eternal life. (Lk. 24:47; Jn. 3: 3; Ro. 10:13 - 15; Eph. 2: 8; Tit. 2:11, 3: 5 - 7)

b) The evidence of salvation

The internal evidence of salvation for the believer is the direct witness of the Holy Spirit. (Rom. 8:16) The evidence external to every person is a life of justice and holiness true. (Eph. 4:24; Tit. 2:12)

6. THE ORDINANCES OF THE CHURCH

a) Baptism in water

The baptismal ordinance by immersion is ordained in the scriptures. All who repent and believe in Christ as Savior and Lord they have to be baptized. In this way a witness is given to the world that he has died with Christ and who together with him has risen to novelty of life. (Mt. 28:19; Mr. 16:16; Acts 10:47, 48; Rom. 6: 4)

b) Holy communion

The Lord's Supper, consisting of the elements of bread and fruit of the vine is the symbolic expression that denotes our participation in the divine nature of our

Lord Jesus Christ (2 Pd. 1: 4) and a memorial of his sufferings and death (1 Cor. 11:26). And a prophecy of his second coming (1 Cor. 11:26) and it is an ordinance for all believers "until He comes."

7. BAPTISM IN THE HOLY SPIRIT

All believers have the right to receive and must fervently seek the promise of the Father, baptism in the Holy Spirit and fire, according to the Lord's command Jesus Christ. This was the normal and common experience in the church early Christian. With baptism comes an endowment of power for life, service, and the giving of gifts spiritual and its uses in the ministry (Lc. 24:49; Acts 1: 4 - 8; 8 1 Co. 12: 1-31). This experience is different and subsequent to new birth experience. (Acts 8:12 - 17; 10:44 - 46; 11:14 - 17; 12:44 - 46; 15: 7 - 9) With the baptism of the Holy Spirit, comes an experience which is like a flood of the Spirit (Jn. 7:37 - 39; Acts 4: 8); a deep reverence for God (Acts 2:43; Heb 12:28); an ardent consecration to God and dedication to the work (Acts. 2:42); a fervent love for Christ, for his for his word and for the lost. (Mr. 16:20

8. THE INITIAL PHYSICAL EVIDENCE OF BAPTISM IN THE HOLY SPIRIT

The baptism of the Spirit in believers is evidenced by the initial sign of speaking in other languages according to the Spirit of God gives them talk. (Acts 2: 4) Speaking in tongues this time it is essentially the same as the gift of tongues (1 Cor. 12: 4-10, 28), but different in purpose and uses.

9. SANCTIFICATION

Sanctification is an act of separation from what is evil and dedication to God (Rom. 12: 1, 2; 1 Thess. 5:23; Heb. 13:12). The Holy Scriptures teach a life of holiness "without which no one will see the Lord" (Heb 12:14). By the power of the Holy Spirit we are enabled to obey the commandment: "Be holy as I am Holy" (1 Pd. 1:15, 16). Sanctification takes place in the believer for his recognition and identification with Christ in his

death and resurrection and for the daily trust in that union and by the continual offering to the dominion of the Holy Spirit of all its faculties. (Rom. 5:11, 13; 8: 1, 2, 13; Gal. 2:20; Phil. 2:12, 13; 1 PS 1:15)

10.THE CHURCH AND ITS MISSION

The church is the body of Christ, the dwelling place of God in the Spirit, divinely appointed for the fulfillment of the great commission. Every believer born of the Spirit is a member of the General Assembly or Church of the Firstborn, whose names are written in heaven. (Eph. 1:22, 23; 2:22; Heb. 12; 23). Since the purpose of God regarding man is to seek and save what was lost, from being adored by man and the edify a Body of believers in the image of his Son, the reason essential to be of this Fraternity as part of the church is:

- a) To be an agency of God for the evangelization of the world. (Mt. 8:10, 19; Mr. 16:15, 16; Acts 10: 8)
- b) Being a corporate body where man can worship God. (1 Cor 12:13)
- c) Being a channel of God's purpose to build a body of Saints who are perfected in the image of His Son. (Eph. 4:11 - 16; 1 Co. 12:28; 14:12).

The Assemblies of God Fraternity exists expressly for give continuous emphasis of this reason for being in the apostolic pattern of the New Testament, teaching and stimulating believers to be baptized in the Holy Spirit. This experience:

- a) It enables them to evangelize in the power of the Spirit with the supernatural signs that accompany it. (Mr. 16:15 - 20; Hch. 4:29 - 31; I have. 2: 3, 4)
- b) Adds a necessary dimension to worship and relationship with God. (1 Cor. 2:10 - 16; 12:14)
- c) It enables them to respond to the full work of the Spirit in expression of fruits, gifts and ministries, for the building the body of Christ. (1 Cor 12:28; 14:12; Gal. 5:22 - 26; Ef. 4:11 - 12; Col. 1:29)

11.THE MINISTRY

A divinely called and ordained ministry has been provided by our Lord Jesus Christ with threefold purpose:

- a) The evangelization of the world. (Mr. 16:15 - 20)
- b) The worship of God. (Jn. 4:23, 24)
- c) The building of a body of saints perfected to the image of His Son. (Eph. 4:11, 16)

12.DIVINE HEALING

Divine healing is an integral part of the Gospel. The liberation from all disease has been provided for us in the atoning sacrifice of Christ. It is the privilege of all believers. (Is. 53: 4, 5; Mt. 8:16 - 17; St. 5:14 – 16)

13.THE BLESSED HOPE

The resurrection of those who sleep in Christ and his transfer together with those who live and stay until the coming from the Lord, it is the imminent and blessed hope of the church. (Ro. 8:23; 1 Co. 15:51, 52; 1 Ts. 4:16, 17; Tit. 2:13)

14.THE MILLENNIAL KINGDOM OF CHRIST

The coming of Christ includes the rapture of the saints, which it constitutes the believer's blessed hope, followed by the visible return of Christ with his saints to reign on earth for a thousand years. (Zac. 14: 5; Mt. 24:27, 30; Rev. 1: 7; 19:11 - 14; 20: 1 - 6)

15.THE FINAL JUDGEMENT

There will be a final judgment in which all the wicked dead are they will rise up and be judged according to their works; and he who was not found inscribed in the Book of Life will be consigned to eternal punishment together with the devil and his angels, the beast and the false prophet, in the burning lake with fire and brimstone, which is the second death. (Mt. 25:46; Mr. 9:43 - 48; Rev. 19:20; 20:11 - 15; 21: 8)

16.NEW SKIES AND NEW EARTH

We, according to his promises, wait for new heavens and a new earth in which justice dwells. (2 Ps 3:13; Rev. 21: 1)

ARTICLE VIII - UNIT TIES

Biblical doctrine, love, and those accepted things voluntarily by all the components of the Fraternity will be our ties of unity.

ARTICLE IX - FRATERNAL ASSEMBLY

The Fraternal Assembly will be made up of all the Ministers with credentials and delegates elected by the Autonomous Assemblies Locals who keep their active membership up to date with this Fraternity.

ARTICLE X-OFFICERS OF THE FRATERNITY OR BOARD OF DIRECTORS

Section 1: The General Official of the Fraternity will meet no less than once a month and will be composed of the Following way:

- a) President
- b) Vice president
- c) Secretary
- d) Treasurer
- e) Director General Ministry of Education
- f) Director General Ministry of the Missions
- g) 3 vowels
 - i. Deputy Secretary General
 - ii. Sub - General Treasurer
 - iii. General Coordinator - Will fill the positions Director of the Ministry of Missions and Education in case of vacancies and will coordinate the activities of the Fraternity at a general level.
- h) Honorary Executive Officers - Founders an International level

- i. Rvdo. Juan A. Echevarria Laureano
- ii. Rvdo. Tomás Rodríguez Pagán

(Ver Reglamento Artículo III Sección 7 incisos A, B, C, D)

Section 2: The General Directory will be made up of the Executive Board plus all Presidents District if there is no District organized the President of the Chapter or conference will be part of the Directory. And it will meet no less than 4 times a year.

ARTICLE XI - DELIBERATIVE ASSEMBLIES

There will be an annual Deliberative Assembly in March which will be our convention.

ARTICLE XII - LAWS THAT GOVERN US AND PARLIAMENTARY PROCEDURES

- a) The Word of God understand the Holy Bible will be our supreme code of ethics.
- b) The Constitution and Regulations that govern us.
- c) The State Laws that regulate our Corporation.
- d) Love, tolerance and understanding in the Spirit of God.
- e) Common sense.
- f) Parliamentary rules. Reece B. Bothwell

ARTICLE XIII – DISSOLUTIONS

In the event of dissolution of an autonomous local assembly, its properties will go to the central offices of the Fraternity and can only be used for new works for what would be property or restricted fund for such purposes. Except those individual properties in which valid and official documentary evidence is presented in this regard.

ARTICLE XIV – AMENDMENTS

This Constitution may be amended in Ordinary Assembly or Extraordinary with the vote of two thirds (2/3) of the constituents of the Quorum in said assembly.

REGULATION

ARTICLE I - DELIBERATIVE ORDER

In its assemblies or deliberative meetings, it must prevail order, respect, and mutual love. To guarantee this, a parliamentary order according to the rules of said discipline. Will be adopted the manual. Reece B. Bothwell.

Section 1: The agenda of the annual meeting will be prepared from according to the following order:

- a) Organize the Assembly by calling it to order and declare it open.
- b) Verify the quorum through the registration of active members who constitute the assembly.
- c) Reading of pending minutes.
- d) Reports
 1. President General
 2. Vice - President General
 3. General secretary
 4. General Treasurer
 5. Other General Officers
- e) General Officers Elections
- f) Other reports
- g) Resolutions
- h) Other issues
- i) Closure

Section 2: Resolutions

Any resolution will be discussed and approved by the Directory of the Fraternity. It will be submitted to the General Assembly for approval end, taking into consideration that it arrives at least 20 days in advance and 2/3 parts of the votes cast at said assembly will be necessary for your approval. Any resolution of the people must come not less than 60 days before the Board of Directors.

ARTICLE II -NOMINATION AND CHOICE OF THE GENERAL OFFICERS

Section 1: General Officers

The Officers of the Fraternity will be a President, a Vice-President, a Secretary, a Treasurer, a Director of Education and a Director of Missions and three members: Member 1 - Under Secretary, Vocal 2 - Sub Treasurer and Vocal 3 – General Coordinator.

A. Requirements

1. The Fraternity General Officers will be elected from among its members and must be present at the assembly.
2. They must be ordained and known ministers for the whole brotherhood. Must be a leader proven you have shown success in your ministry.
3. Must be or have been a pastor on property for five years from an established church. Of be an associate pastor, it is required to be over eight years of a church over one hundred and fifty members in full communion and always have been as a minister with credentials.
4. Must not be under 25 years of age.
5. With vast experience and maturity in ministry. With good testimony among the faithful and strangers.
6. Graduated from a Biblical Institute recognized or have a ministry established evidence of approval divine.

B. Term duration:

The term of the General Officials will be two years and may be reelected. The term of the General President will be for two years and may be reelected for three consecutive terms and may continue in office for as long as you get two thirds of the votes cast in the nomination ballot. They will take possession of their charges no later than a month after the choice. The expiration of its terms will expire alternately.

C. Nomination and Election

All officers for such positions will be nominated and elected by secret ballot in the corresponding assembly. A nomination with two thirds parts (2/3) of the votes cast will constitute an election provided that the candidate fill the requirements and qualities for the position. After the third ballot only three people that prevail in the vote will be considered for subsequent voting and after the fifth ballot only the two with the most votes if there is no election.

Section 2: Vacancies:

If a vacancy arises, the corresponding vowel will fill said vacancy. From being that of the President General, the Vice - President will assume the position. In all cases At the next Annual Meeting the vacancy will be filled.

Section 3: Form of election:

Every election will be made by secret ballot and two thirds (2/3) of the votes cast will constitute choice. There may be a choice on the ballot nomination.

ARTICLE III - DUTIES OF OFFICERS**(As Board of Directors)**

They will meet no less than once a month and more than half of the members that compose it will constitute the Quorum. No Official may act individually as owner and lord of the Corporation assets.

The President General

- A. Preside over all body meetings Board of the Fraternity and all general assemblies. He will preside over any meeting that your position demands you.
- B. He will be the Pastor General of the entire ministry of the fraternity.
- C. It will be the standard bearer of vision, plans and objectives of the Fraternity and will set them written for the entire ministry to join work with him to achieve it.
- D. You will be an ex officio member of any meeting led by other officers. You will be summoned to such meetings.
- E. He will be jealous to respect and make the sovereignty and autonomy of local churches and their assemblies. Will always be willing to collaborate with these at their request.
- F. Maintain discipline and manage it as established in these Regulations.
- G. You will be a resident agent of the corporation in accordance to the Laws of the State.
- H. Give a written report of the work done at the General Assembly.
- I. It will keep your team informed of his work and vision.
- J. You can be pastor of a local assembly and not to be, he will be a member of some of them; but i know refrain from influencing the internal affairs of said church.
- K. He will chair the Credentials Committee and will be firm authorized therein together with the Secretary General.

Section 1: The Vice - President General

- A. Assist the President General in his duties.
- B. Will always be ready to do work that are delegated to him by the Governing Body.
- C. He will assume the position of President General in case of resignation, death or prolonged illness of the President General.
- D. Submit a written report of your work at the Annual Meeting.

Section 2: Secretary / General Secretary

- A. Will take everyone's minutes the meetings in the official minute book. Such minutes will never be considered read and must be approved and signed at the corresponding meetings.
- B. Custody of all official documents of the Fraternity and the seal of the Corporation.
- C. He will sign the credentials of the ministers together to the President General and will be responsible for his processing. Will sign all official documents of the Fraternity.
- D. Keep all statistics up to date.
- E. You will be informed of any meeting in which there may be conflict with their functions.
- F. It will render an annual report to the assembly.

Section 3: Treasurer / General Treasurer

- A. He will be the custodian and custodian of all funds and Fraternity properties.
- B. It will be authorized in the Bank in which the deposit the funds with the President and / or General secretary.
- C. It will render an annual report on the fiscal status of the Fraternity at the annual meeting.
- D. It will keep the General Directive informed in financial and fiscal terms of the Fraternity in their corresponding meetings.
- E. It will be kept from not using or allowing the illegal use of the funds of the Fraternity.
- F. It will be evidenced by canceled checks, invoices and I receive all disbursements from the treasury.
- G. In cases of audits, you will not refuse to present all the evidence required by it.
- H. Together with the President General, he will be responsible for all the tax operations of the Fraternity.
- I. Prepare the annual budget with the President General and the Finance Committee and will chair said committee.

Section 4: Director General Ministry of Missions

- A. Preside over all the meetings of this Ministry.
- B. Will be responsible for organizing and implementing all programs and functions of this Ministry following the provisions of these Regulations.
- C. Represent the Ministry of Missions on the Board General.
- D. Represent the Ministry of Missions where and when necessary.
- E. Perform other tasks delegated by the Board General or the President General.
- F. Serving visitors when considering problems related to the missions or the Fraternity General.
- G. Will provide a comprehensive report of the work of the missions both to the General Directive as to the General Directory in their respective meetings and a full report at the Annual Meeting.

Section 5: Director General Ministry of Education

- A. Preside over all meetings of the Ministry.
- B. Will be responsible for organizing and implementing all the programs and functions of the Ministry following the provisions of these Regulations, including everything concerning the School Sunday. See Art. X Sec. 6.
- C. Represent this Ministry in the General Directive and the General Directory.
- D. Serving visitors when considering problems related to the Ministry of Education or the Fraternity in general.
- E. Represent the Ministry of Education where and when necessary.
- F. Perform other tasks delegated by the Board General or the President General.
- G. Will provide a comprehensive report of the work of Education so much to the General Directive as to the Board at their respective meetings and a full report in the Assembly Annual.

Section 6: ELDERLY COUNCIL

This Corps of Honorary Executive Officers International founders and additional ones, will function, as necessary, as the Appeals.

- A. These will be just those officials who were original founders of FIADAH in Puerto Rico and they keep their total loyalty and loyalty to this organization or any Executive officer that is maintained for twelve consecutive years or more as such. Being the two founders' originals.
 - i. Rvdo. Juan A. Echevarria Laureano
 - ii. Rvdo. Tomás Rodríguez Pagán
- B. With all the rights and duties of others elected Executive officers while they remain renewing their credentials with FIADAH International.
- C. That this article take effect for each of them in the moment when each cease their roles as active elected officials of FIADAH. These Officers must be summoned to actively participate in all meetings of the Executive Committee, the General Directory and of course from the Annual Meeting.
- D. The current Honorary Executive officers will constitute the Appeals Committee before which matters that they can cause serious conflicts or insurmountable between the body of elected General Officers. Too they will be asked to preside over the election of the President General. In extremely situations necessary, may act as an audit committee if two thirds of the Honorary Officers that make it up, they agreed.

ARTICLE IV – COMMITTEES

Section 1: Standing Committees

These committees must be in existence always although their members can be changed. They will be named by the General Directive.

- A. **Credentials:** It will be made up of the Directive General.

- B. **Finances:** They will help to raise the finances of the Fraternity and watch over its good use. They will help prepare the budget together with the Treasurer and the President General.
- C. **Supervision and evaluation of elections and deliberative assemblies.**
 - 1. They will supervise the Registration Committee.
 - 2. They will be given a complete report by said committee including the ballots that constituted elections to be corroborated.
 - 3. They will render a report to the General Directive as soon as they have it ready and no later than one month after the assembly or election correspondent.
- D. **Public relations committee.**

This will be in charge of the promotion and information of all the activities of the Fraternity and with due care disclose our position in public affairs when necessary. For the latter will be mandatory to first meet with the General Directive.
- E. **Residency and Discipline Committee. (Go to Art. VIII)**

Section 2: Special Committees

These will be appointed to coordinate the Annual Assembly or any other assembly that be of character General. I know they will name with three months in advance of the event and this will be done by the Board of Directors General.

J. Reception and protocol

ARTICLE V - LOCAL ASSEMBLIES

Section 1: Affiliation

Congregations with twenty or more active members over sixteen (16) years. These will be the churches pastored by our ministers and whose local sovereignty and autonomy will be Sacredly respected. They will have the right to send a delegate to the General Assembly or as stipulated in the Regulation of the Fraternity. They may request the help and advice from our General Officers as they deem necessary. All the shepherds of our Fraternity will be Affiliated to it. The same that the churches in order to send your delegate to the annual assembly. The fraternity may provide pastors to churches. If the local assembly needs the help of the Board General for organize your local regulations, may request it through the Secretary or General Secretary of the local church. All churches locals will send an offering voluntary monthly to the Fraternity in proportion to the growth in assistance to it. A suggestion that we give it could be \$ 10.00 for every 25 attendees.

Section 2: Principle of Equity, Literality and Autonomy Fiscal

- A. While the FIADAH does not intend to intervene in the internal government from local churches there where it has made an investment substantial will have right to property in proportion to what invested until much said debt is paid off.
- B. FIADAH is not a loan agency. In its due time will have your agency legalized for that purpose, for which affiliated churches must use their sovereignty to Finance your own projects.
- C. Where FIADAH has initiated a work will have heritage of the same until the work becomes autonomous and sovereign. Then having been released from all liens financial in which

FIADAH has incurred in the process of its administration until that moment.

- D. Any property lien established between a Local Church and FIADAH will be duly documented and signed by official representatives of both institutions as well as the release of the same.

ARTICLE VI – MINISTRY

Section 1: Description and basis of the ministry

In Ro.12: 7, 8 and Ef. 4:11 on these Biblical passages Appear different ministries to be carried out in the work of Sir. This does not mean that everyone needs a credential authorized by the Fraternity to exercise it.

Section 2: All our ministers shall have a credential from the Fraternity which will serve as identification and confirmation of legitimacy of your call, evaluation, and ratification of its competence ministerial.

Section 3: Required Qualities

- A. To have been born of New like says Jn. 3: 5 and be well affirmed in the gospel and in your convictions Christian. Ef. 6:14.
- B. Have received the baptism in the Holy Spirit.
- C. Already have a evidence of fruitful ministry that merits having a ministerial credential of the fraternity.
- D. A faultless testimony. (1 Tim. 3: 1-13, Tit. 1: 7)
- E. A foundation doctrinal consonant with those of the Fraternity.
- F. Knowledge of our Regulations and submission to them.
- G. Studies in Theology that show his ministerial preparation or a established ministry that evidence divine approval.
- H. That meets all ministerial requirements including everything what is contemplated in art. IX. Fraternity

reserves the right to honor or not transfers of ministers who come from other organizations.

- I. They will fill out and complement an application for income with a fee of \$ 50.00. (In the Republics out of port Rico and the United States will pay (\$ 10.00) or its equivalent in their own currency).

Section 4: Ministerial Ranks

A. Certified Minister

These will be received as candidates for ministry and will remain at least for five years to no be that start one new work or are in a ministry recognized and respectable. Your promotion will be assessed based of his ministry.

B. Licensed Ministers

These will be pastors who have spent no less than three years in the pastorate or in a recognized and respectable ministry. After what which may request promotion which will be evaluated by the Credentials Committee (they will fill out and will complement promotion request).

C. Ordained Ministers:

These are those people who fill all the requirements according to the Word (1 Tim. 3: 1-7, Tit. 1: 7-9).

1. Be over 21 years of age.
2. Spend interviews and required exams.
3. Must have passed the rank of Licensed Minister.
4. Must be active in ministry.
5. His loyalty to God, the ministry, and Fraternity will be of commitment.

Section 5: Certificates

Every minister accredited by the Fraternity will possess a certified or credential with photo that identifies him as an active minister and recognized by the same.

Section 6: Ministerial Relations

A. Commitment

All our accredited ministers will respond to you to the Fraternity in terms of doctrine, conduct and economic support.

B. Components

Essentially this will be a Fraternity of ministers though the churches will have the right to send delegates.

C. Financial responsibility

All Ministers will fully decimate the Fraternity except for the Certified Ministers who will decimate the half to the Fraternity and half to your local church, not being a pastor who will then decimate everything to the fraternity.

D. Credential Renewal

All ministers who are faithful titers and keep complying with all others requirements of an active minister including the corresponding payment of his annual fee of seventy-five (\$ 75.00 (The ministers of the republics out of port Rico and States United will pay twenty five (\$ 25.00) dollars or its equivalent in your own currency), to keep your active membership at FIADAH, Your credentials will be renewed free of charge. Of In any case, the fill out the forms for renewal of credentials and send them to general administrative offices at least one month before their expiration.

E. Any minister who does not fill out their renewal at the time of expiration will have to pay five (\$ 5.00) dollars for each month that elapse after expiration.

Section 7: Rights and privileges

A. Every active minister recognized by the Fraternity will enjoy your support.

B. They will have the right to speak and vote in the assemblies Generals except for the Ministers Certified without pastorate.

- C. They will have access to all correspondence public of a Fraternity.
- D. They will have access to seminars, magazines, training, etc. that promotes Fraternity.
- E. They will have access to all the benefits that offer the Fraternity.

Section 8: Ministry Training and Follow-up Department

- A. This Department will have a Director on which will be an Ordained minister appointed by the President and Pastor General, in consensus with the Executive body and the confirmation of the Board of Directors General.
- B. The term of service of said Director will be for two years, or those that the fruit of their executions, to judgment of the Executive Body and the General Directory deem convenient.
- C. The Director of this Department may appoint a Secretary and a Treasurer, or one that combines both positions. This will be confirmed by the FIADAH General Directory. All appointments will be made in harmony with the person's local pastor. be named.
- D. This Department will have a regulation of internal operations consonant with the Constitution and FIADAH Regulations and ratified by the General Directory.
- E. Said regulation will collect and incorporate its content all the substance poured into the By how many of the Resolution approved for the authorization of its existence, because represent in themselves the explanatory memorandum for its creation.

ARTICLE VII - CHAPTERS, CONFERENCES, DISTRICTS

Section 1: Chapters

The word chapter is defined as a group of ministers and churches that can meet geographically comfortable for fraternize and not group less than seven churches affiliated with the Fraternity. These ministers will elect a President and a Secretary - Treasurer among them who will be aware of promoting the unity and harmony of the Chapter. Within the island of Puerto Rico, the chapters may be of up to twenty (20) churches and it They will organize as many as necessary since there is no will convert in conference.

Section 2: Conferences

When outside the island of Puerto Rico there is some substantially large and populated territory where more than ten churches affiliated to the Fraternity, the creation of a Conference will be authorized. This will elect a board of directors composed of a President, Vice-President, a Secretary, and a Treasurer.

Section 3: Districts

In Puerto Rico there will be as many districts as comfortable geographical areas are available to facilitate fraternization and have more of 20 churches affiliated with the Fraternity. The prudence harmony and need that the distances geographical demand in creation of new districts. Out of port Rico Conferences one Once they grow to more than twenty (20), the creation of districts and the same discretion will be used as In Puerto Rico in its proliferation. Said District shall elect from among its members a Board composed of a President, a Vice-President, a secretary and a Treasurer and they will respond to the General Directive of the fraternity.

Section 4: Fiscal year and elections

The fiscal year of each chapter, conference, and district as well as their elections will coincide for reorganization and reporting purposes with that of the Fraternity. General. In order to report to

the Annual Assembly of the General Fraternity, they are will allow your fiscal year there will be and close not less than a month before of the Annual Assembly of the Fraternity that It will be effect during the month of March of each year.

Section 5: Chapter and Conference Officers

A. Chapter and Conference President

1. Requirements

- The Presidents of the chapters must be ordained ministers.
- Conference officers will be all ordained ministers, with each other requirements than for executive officers.

2. Duties of the President of the chapter or conference

- Supervise and guide workers and churches of your Chapters or Conferences and be aware of all the activities and movements of these.
- Preside over the monthly and special meetings of your Chapter or Conference.
- Immediately address issues or problems of workers and churches and surrender immediately written report and communicate the matter to the General Executive Directive.
- As far as preachers or lecturers that are not of our fraternity will consult previously with the General Executive President and in his absence with an immediate officer.
- Prepare in harmony with President and Secretary General requests and local church nominations to fill pastoral vacancies.
- Advise and guide the Assemblies premises for the selection of pastors and help them as requested by them.

- Follow up on workers without pastorate in their respective ministries.
- They will be responsible for evangelization of the territory covered by its Chapter or conference, to maintain life spiritual of this and to carry out the financial plans and activities of the Fraternity.
- Submit a written report of the work made every three (3) months to the Board of Directors General. They will also render a report of the work done at the annual meeting of his Chapter or Conference and they will send a copy to the office of the Fraternity for its file.
- They will prepare a work plan and calendar of written activities of your Chapter or Conference in harmony with the plan work of the General Fraternity.
- They will have the duty to appear at the meetings of the General Directory and inform all matters related to your Chapter or Conference.

B. Chapter Secretary-Treasurer

These will be elected from among the members of the himself, in a meeting called for such purpose.

1. Requirements

- Must be an Ordained or Licensed Minister who has the ability for the position and is a faithful achiever of his duties.
- You must have attended most of the meetings of your chapter.

2. Homework

- As Secretary, he will keep minutes of all your chapter meetings.
- It will keep a directory of your chapter.

- Prepare the calls for the meetings of your chapter and send them in time.
 - As Treasurer, he will keep a record of tithes and Offerings and deposit in the FIADAH account and send a report with the deposit sheets, to the General Treasurer.
- C. Conference Vice-President
- Requirements and duties
1. He shall assist the President in his functions.
 2. He will always be ready to carry out tasks assigned to him by the board of directors.
 3. Will give a written report of their work in meeting of your Conference.
 4. You must have attended most of the meetings of your Conference.
- D. Conference Secretary
- Requirements and duties
1. It will always be present at official meetings.
 2. It will take the minutes of each meeting.
 3. It will keep up-to-date statistics of your conference.
 4. You will submit an Annual Report to your conference.
 5. You must have attended most of the meetings of your Conference.
- E. Conference Treasurer
1. Keep a Record of Tithes and Offerings.
 2. It will make the deposits in the name of FIADAH.
 3. Will send a report with their deposit slips to the office.
 4. You must have attended most of the meetings of your Conference.

Section 6: District Officers

Requirements

They must be ordained ministers, with the other requirements than for executive officers.

A. District President

1. He shall preside over the meetings of his District.
2. Prepare an annual work plan in harmony with that of the Fraternity.
3. He will be a member of the General Board and in his district shall be an ex officio member of all commissions thereof.
4. He will assist within his availability the leaders of his District.
5. He will meet as many times as necessary with his district officials.
6. Submit a report annual writing in the Fraternity Convention.
7. Being a pastor or member of one of the churches affiliated with our Fraternity.

B. Vice - District President

Requirements and Duties:

1. He shall assist the President in his functions.
2. He will always be ready to carry out tasks assigned to him by the board of directors.
3. Will give a written report of their work in your district meeting
4. You must have attended most of the meetings of your District.

C. District Secretary

1. It will always be present at official meetings.
2. It will take the minutes of each meeting.
3. Keep your district's statistics up to date
4. You will file an Annual Report with your district.
5. You must have attended most of the meetings in your District.

D. District Treasurer

1. Keep a Record of Tithes and Offerings.

2. It will make the deposits in the name of FIADAH.
3. Will send a report with their deposit slips to the office.
4. You must have attended most of the meetings of your District.

Section 7: Election and Term Duration

- A. Chapter officers will be elected annually, being able to be reelected if the components of the Chapter so decide.
- B. Conference officers will be elected every two years and may be reelected as provided your own assembly.
- C. District officers will be elected every two years and may be reelected as provided by their own assembly.
- D. If there are vacancies before the end of the official term, an interim will be appointed with the help of the General Directive of the Fraternity to conclude the term of office.
- E. All election will be made by secret ballot and two thirds of the votes cast will constitute choice. There may be election on the nomination ballot.

ARTICLE VIII - RESIDENTIALITY AND DISCIPLINE

Section 1: Need for discipline

All discipline will be directed with love and out of love (Heb. 12: 5 - 11) to maintain purity and welfare of the Fraternity in general and the work of the Lord.

Section 2: Purpose

Restore and achieve a fruit worthy and peaceful of Justice. (Heb 12:11)

Section 3: Procedure

- A. **Investigation Committee** - All Presidents of Districts and where there are no Districts, the Directory the General shall appoint such Committee by majority. and this one will interview the people involved, they will collect documentary and testimonial evidence, and will render a duly documented report to the Decision Committee.
- B. **Decision Committee** - It will be composed of the General Directory and the Research Committee.
- C. **Inhibitions** -When the person whose discipline is in question or a familiar yours be part of such committee, will be inhibited for obvious reasons.
- D. **Rumors and Comments** - No discipline will be carried out, nor any investigation that is based only on rumors or comments, but through signed written complaints or certified.
- E. **Evidence or Evidence** – It will consider evidence or evidence that can be documented or that eyewitnesses appear or circumstantial personally appear before the committee to testify or confirm certified and confirmed statements.
- F. **Reports** - A well done report will be prepared, well documented by the Discipline Committee and the person whose discipline is in question and you will be informed of the situation and the report. This constitutes the charges themselves.
- G. **Judgment**
 - 1. If the person accepts guilt and shows repentance you will be given the following options:
 - Voluntarily resign your position and stay in the Low fraternity observation for a year at the end of which he will be declared rehabilitated if his behavior warrants it.
 - If the offense was not so serious, you will be warned and forgiven if it is the first occasion that such conduct occurs. The The full

committee will determine what will understand a serious offense based on what the majority of 2/3 of the quorum of the committee, decide in meeting.

2. If the person does not accept guilt but the committee by said majority determines that the person is guilty, will be disciplined for three years, two of which will not have participation in the local church or in FIADAH. From the second year you can start your activities in the local church whose pastor took over from him at the time of discipline.
3. Equity - If the accused person turns out that he is innocent and the evidence is in his favor, then the discipline will be administered to the accuser if he is a member of the Fraternity. Of otherwise the injured person will proceed in the way that you understand convenient.

Section 4: Residence

- A. **Committee** - The Honorary Officers Committee may and you must intervene, if you understand it prudently and necessary, in this process, always in benefit of the spiritual, moral and fiscal health of the fraternity usually. (See Art. III Sec 7 subsection D).
- B. **Cause** - Any officer who takes an attitude dictatorial and you find rape this Constitution and Regulations may be resided from his elective position.
- C. **Process**
 1. The case will be submitted to the Investigation Committee signed by the plaintiff or citing the constitutional violations.
 2. Such complaints will be reported to the officer in question.
 3. A tribunal shall be constituted consisting of the Decision Committee members

4. The officer in question will be given the opportunity to appear before said court to give the relevant explanations.
5. If the court's decision was to reside you in his elective position, said decision will be valid if two thirds $\frac{2}{3}$ parts of the members of the court so decide.
6. Said court will be chaired by the official highest ranking in the General Fraternity in both and as long as he himself is not the person to be resided. (See Art. VIII Sec. 4 - Inc. a).
7. If any discipline were to be imposed it should be processed as established in this article.

ARTICLE IX- POSITION ON MARRIAGE, WIDOWS, DIVORCE, RESTRAINT, GENDER AND SEX

Section 1: Marriage

Marriage instituted by God and approved by the people of God according to the Holy Scriptures, and especially by the church, is the one contracted by one man and one woman.

Section 2: Widowhood

A person is truly a widow when your original husband or wife dies. Such a person, according to the Holy Scriptures, he is free to get married if you want to.

Section 3: Divorce and Repossession

The church must discourage and avoid divorce at all times. Solemnize weddings between people divorced, except for fornication or adultery, is counterproductive to the Word of God, and to the Church doctrine around marriage and at the same time tends to weaken it.

Section 4: Ministerial Credentials

Because in Hebrews 13: 4, the Bible says that fornicators and adulterers will be judged by God, it is not for us to judge. There are some people who being married, we see that they have received a call from God to the ministry, they have accessed to obey him, and God has blessed them or has raised them as ministers and his ministry has become recognized and supported by the community of faith. If the person has not caused scandal and said ministry is such, that before his testimony, his marked success and growth it see an endorsement from God, they should be issued a credential ministerial if the request a once examined the situation by the Credentials Committee and if they meet and meet all the other requirements and this of course if they go to affiliate his ministry to our Fraternity.

Section 5: Position on Gender and Sex

God created human beings for the purpose of reproducing and multiplying by generating sons and daughters, for all of which he created only two genres that are consequently identified as masculine and feminine, by reason of the sex with which God he created the one and the other distinctly. Hence the FIADAH INTERNACIONAL sustains itself in this reality Biblical and Doctrinal. Therefore, all our ministers will uniformly submit to exercising their ministries within this biblical and doctrinal position. All disobedience to God and His Word is sin. It is because of the sin that have arisen in society practices that are against nature, such as: homosexuality, lesbianism, bisexuality, promiscuity, sexual abuse, transgenderism and transsexualism, pedophilia, sodomy and violence gender and / or domestic and incest. The role of minister and of the church is to bring all who practice such things to have a personal meeting and true with God in a way that leads them to understand what is sin and what is degeneration, so that they repent before God, prepare to change and consequently be forgiven and regenerated. The Bible is clear about all these things, for which, our official position is sustained with the following Biblical appointments among many others: Gn. 1: 26-28; 2:24; chap. 19; 34: 7; Lv. 18:22; 20:13; Prov. 6: 24-26 and 32-35; Isa. 5:20;

Ro. 1: 26-28; 1st Co. 6: 9,10; 7: 2; Ef. 5:31; 1st Ti. 1: 9,10. No wedding or marriage will take place that is not between a man and a woman as well it is established by the Word of God. Gn. 2:24; 1Co. 7: 2; Ef. 5:31.

ARTICLE X- ORGANIZATION OF THE WORK EVANGELIZING AND MINISTRY OF CHURCHES

Section 1: The Missionary Work

Both at the level of the Fraternity and the Local churches will organize a missionary ministry for:

- A. Fellowship and promote a spirit and environment missionary.
- B. Promote the calls and identification of the people called by the Lord to go out to the mission field.
- C. Endorse and dismiss appropriately and within the harmony of the church to those commissioned people to the mission field.
- D. Pray for the missionaries.
- E. Raise funds and offerings for support of said missionaries.
- F. A directive of that ministry no less than three people for carry out work at all levels.
- G. Local churches will have the freedom to organize within their autonomy and sovereignty as you see fit.

Section 2: Evangelism

In the Fraternity a no committee less than three people who plan, organize, distribute, and supervise the evangelistic work within the vision and harmony of the unity of love that promotes the Fraternity

- A. The minister Evangelist - these will be ministers in the range that qualify within the ranges Ministerial recognized by the Fraternity; must be members of a church affiliated to the fraternity.

- B. The lay Evangelist - churches can recognize from among its members those who worthily carry out evangelistic work and credit them as such locally.

Section 3: The Fraternities

Both at the level of the Fraternity and the churches locals will group people by fraternities with the in purpose of facilitate the work of integrating people into the church, fellowship, participation and the spiritual, theological and numerical growth of church. Each will have a composite directive by the number of people deemed necessary. Examples of grouping by fraternities:

1. Fraternity of Knights
2. Ladies Brotherhood
3. Youth Fraternity
4. Child's Church

Section 4: Reorganization Fraternities

The Directory General will be the forum to which the Directives Nationals and general of all Fraternities report your work done annually and be this forum the one with the authority of determine the duration of the term that each member of said directives will remain incumbent on the light of the work that each one has carried out. This will be done at the first Board meeting General immediately after the election of the presidents of Chapters and always after of the FIADAH Annual General Convention. Than the three members of the General Directive are the ones who serve as liaison officers in the Executive for said Fraternities and they are rotated every two years for everyone to get to know the dynamics of each Fraternity and avoid routine and stagnation.

Section 5: Alternate Childhood Programs

- A. **Extreme Adventurers** - for boys and girls of ages 5 to 18 years. (See organizational structure of this program)

Section 6: The Sunday school

Both at the level of the Fraternity and the local churches a Steering Committee will be established composed of three or more people who direct this work:

- A. Group people by class groups.
- B. Stay on top of the literature necessary and corresponding.
- C. Promote spiritual, theological, and numerical at all levels.
- D. Keep statistics up to date.
- E. Promote the possession, reading, study and practice of the Sacred Book, The Bible.
- F. Promote training seminars for Sunday School teachers and / or Groups Relatives.
- G. Promote the observance of the Lord's Day.
- H. Others.

Section 7: Family groups

These are groups that with the authorization and The Pastor's supervision meets by the homes on the designated day in harmony with the program of each church. These groups will help the integration of their members into the local church.

ARTICLE XI - QUORUM

Section 1: Quorum

All ordained, licensed ministers and certificates that are credentialed pastors officially registered assets will be authorized to have a voice and vote in the Assembly. Everybody delegates from duly constituted churches, and pastured by ministers of the Fraternity will be part of the Quorum with the same rights

ARTICLE XII – AMENDMENTS

These regulations may be amended in ordinary meeting or extraordinary as long as its purpose is announced with a term of not less than twenty days in advance to the members of the

Fraternity. Must be approved by one vote favorable not less than two thirds (2/3) of the votes cast.

ARTICLE XIII – VALIDITY

These Regulations will come into effect from our Constituent Meeting with dated December 22, 2001 year of our Lord and in the historic town of Lares, Puerto Rico and it will be ours Magna Carta without that it can be repealed although yes it can be amended according to the advancement of the work.

ARTICLE XIV - OF THE INTERNATIONAL LEVEL

Section 1: The Constitution and Regulations

- A. Every nation outside of Puerto Rico, the United States of America and its territories will have to adapt this Constitution and regulation to your reality geographic and legal or will draft one as long as it is in harmony with the general reality of FIADAH and with this Constitution and Regulations. The General Directory will pass judgment on the same before being approved by the General Assembly of the respective nation.
- B. To guarantee a spinal uniformity each Constitution and National Regulations must ensure that the following are included in it elements:
 - 1. That the name of the entity that identifies us to everyone be

Hispanic Autonomous Assemblies of God International Fraternity with its acronym FIADAH

- 2. The sixteen fundamental truths will constitute our body of doctrines Biblical - Art. VII - intact.
- 3. Puerto Rico will be identified as Headquarters Principal.

4. That the credentials of each minister will only be issued by the headquarters in Puerto Rico so that they are valid unless mutually agreed otherwise.
5. That the FIADAH logo is the distinctive logo that externally visible identifies each affiliated church in each nation.
6. That the preamble and the epilogue are included intact.
7. That our motto in short is UNITED FOR LOVE and the slogan will be:
In the doctrinal, firmness
In the non-doctrinal, tolerance
In brotherhood, harmony
United for love

Section 2: Of the International General Directory

A. Composition

The General Directory will be made up of all members of the General Board of Puerto Rico and the President General of FIADAH of each nation or its official representative.

B. International General Directory Meeting

This will take place every three years and said meeting will be held in a different nation from those affiliated to FIADAH on a rotating basis. Puerto Rico will retain the right to claim them.

C. Annual representation expenses General Board of Directors International

When the meetings of the General Directory International occur in Puerto Rico, the expenses of transportation of the representative of each nation will be paid by the FIADAH headquarters and will provide lodging. In the year the meeting was give outside of Puerto Rico only to the representation of Puerto Rico will cover your expenses. Every FIADAH National will cover the expenses of its representative.
